In consideration of the services of Teton Whitewater, LLC, their officers, agents, employees, and all other persons or entities associated with those businesses (hereinafter collectively referred to as "TW"), I agree as follows:

Although TW has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, TW has informed me that this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of this activity. These inherent risks are some of same elements that contribute to the unique character of this activity and can be causes of loss or damage to your equipment, accidental injury or illness, or, in extreme cases, permanent trauma or death. TW does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks:

Natural river features will be encountered, including rocks, trees fallen or not fallen, swift currents and other hydrologic features. I can be jolted, jarred, bounced, and shaken about during rides through some of these natural river features. It is possible that I could be injured if I come in contact with fixed equipment necessary to the operation of the expedition and the outfitting of the raft. I could be "washed" overboard, or underwater. Accidents can occur getting on and off the raft. Rafts are slippery when wet. Exposure to the natural elements can be uncomfortable and/or harmful. I am aware that this exposure could cause sunburn, dehydration, heat exhaustion, heat stroke, and heat cramps. Also, prolonged exposure to cold water can result in hypothermia, and in extreme cases, death and accidental drowning is also a possibility. Inclement weather such as rain, sleet, snow, thunder and lightning may be encountered.

I am aware that this activity entails inherent risk of injury or death to myself. I understand that the description of these inherent risks is not complete, and that other unknown or unanticipated risks may result in injury or death. I agree to assume responsibility for the inherent risks identified herein and those inherent risks related to the sport of river rafting not specifically identified. My participation in this activity is purely voluntary; no one is forcing me to participate, and I elect to participate in spite of these risks.

I acknowledge that engaging in the activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of TW has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am completely capable of participating in this activity. Therefore, I assume full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death or loss of personal property and expenses thereof as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.

I have carefully read, understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate, and for all members of my family, including minor children.
